# Newsletter Creating Safer Space June 2022



#### Welcome

Creating Safer Space is an international research network, which aims to understand and support unarmed civilian protection and self-protection amidst violent conflict.

In this edition of the newsletter, we are delighted to announce the outcome of our recent funding competition. We look forward to supporting 13 research projects that will further our understanding of unarmed civilian protection and self-protection amidst violent conflicts around the world. We received a large number of applications for funding, and we regret that we were not able to fund all high quality projects.

Drawing upon insights from the funding panel meetings, the *Creating Safer Space* network invites you to an event where we will share top tips on how to write a successful grant application. This will be relevant for anyone who is planning to write a research grant application in the future, for any funder, regardless of whether you applied for our grant schemes or not.

#### **Outcome of Funding Competition**

The *Creating Safer Space* network has recently held a funding competition, and we have awarded funding to 13 research projects that will further our understanding of unarmed civilian protection and self-protection amidst violent conflict.

Projects will focus on the core countries of the *Creating Safer Space* network – Colombia, South Sudan, Myanmar and the Philippines – and we are also pleased to support projects in Cameroon, Palestine and Nigeria.

Four of the successful projects are led by organisations in the Global South. The remaining are led by UK universities, but all include co-investigators and/or project partners from the Global South.

The *Creating Safer Space* funding panel was impressed with the high quality of the applications. We received 59 applications in total, of which 50 projects met the basic eligibility criteria. We sincerely regret that we are not able to fund all high quality projects.

We received 29 eligible applications for our Large Grant scheme, and were able to fund 6 projects. We are pleased to announce the successful projects:
